

INTERNATIONAL POSTER CONTEST – PIŃCZÓW 2015
Regulations of the contest

I. The objective of the contest is to design and create a poster on the following theme:

No Borders – 10 years of partnership and cooperation of Pińczów, Tata, Svodin and Bystrice

The poster should depict intentions and reflect personal feelings of the author on the theme of the contest.

II. Contest organizers:

III. Time and place of submitting works:

1. Paper works should be delivered at address:

Deadline of entry period is 10th June 2015.

2. The paper version of the work should be accompanied by its electronic version, sent to the e-mail: psck@psck.pl in .jpg, .jpeg format.
3. The paper version of work should be accompanied by a completed submission form.

IV. Terms and conditions of participation:

1. The contest is international and open for participation for children and teenagers from the four partner cities: Pińczów, Tata, Svodin and Bystrice.
2. Participation in Contest is free and voluntary.
3. Each and every author can send at most 1 poster.

V. Technical and formal requirements:

Works should be created with technique of choice in international paper format A3 (297 x 420 mm; ISO 216). On the back of poster, it is necessary to provide the author's data: Name, Forename, Age, Country, and City.

1. Rights granted/copyrights:
The authors of qualified works transfer their copyrights to Pińczowskie Samorządowe Centrum Kultury exclusively and without any territorial or time constraints, with the right to further transfer of the right by Pińczowskie Samorządowe Centrum Kultury to third parties (In accordance with Polish legislation and Civil Code: Article 50 of the Act of 4 February 1994 on about

copyright, consolidated text: Journal of Laws, No. 90, Item 631, as amended).

2. Contestants agree to processing of their personal data at level necessary for contest purposes (In accordance with Polish legislation and Civil Code: Act of 29 August 1997 on Personal Data Protection, Journal of Laws, No. 133, Item 883).
3. Participation in contest means that the contestants agree to the use of their names and forenames in any promotional, informational and commercial actions connected to the contest.
4. Participation in the contest means agreement without restrictions for this regulations of the contest.
5. Contest organizers take no responsibility for any changes or cancelling of contest if have no influence on causes or circumstances which leads to changes or cancelling of the contest.
6. Works can't contain materials or content contradictory to social norms, and polish law. Such posters won't be exposed.

1. Jury will assess the works and determine the winners.
2. Works will be assessed in age categories:

I category: 6 – 9 years old

II category: 10 – 12 years old

III category: 13 – 15 years old

IV category: 16 – 19 years old

VII. Prizes/awards:

The winners of contest will be rewarded with prizes and diplomas in each category.

Contested works will be presented during a conference of V4 Group partner cities.
